The CAA is in the process of becoming an LLC. As part of this process, we are dividing the money collected for rank processing money from the dues. We have made a separate business bank account and opened it with \$5,000 from the dues. This income will be used to run the association and spent on such things, the food at the CAA meetings, web hosting, and expenses related to the LLC.

The money paid by yudansha will remain in the rank processing account and will be spent on rank processing costs (e.g., money sent to Hombu, cost of mailing certificates, etc.).

As of Friday 2/24, the balances in the accounts were:

A) Business: \$3,000 (plus money collected today, minus money paid for pizza)
B) Rank Processing Account: \$4,691.60
C) Pay Pal: \$1,373.46

As bookkeeper, I have been and will continue to monitor and balance all accounts monthly.

The Rank Processing Area of the website has been updated. There are now 2 sections, one for shodan to yondan applications, the other for godan and above. The application forms are now online version since additional people will be entering these applications now that the database is finished.

A new process has been created for shodan to yondan examinations that occur outside of the United States;. These now require a form be submitted to Japan at least three weeks before the actual yudansha examination; the Delegation of Examination Form. In the case of multiple exams on the same day/weekend, the dojo cho should send an email with a list of all applicants and the date.
